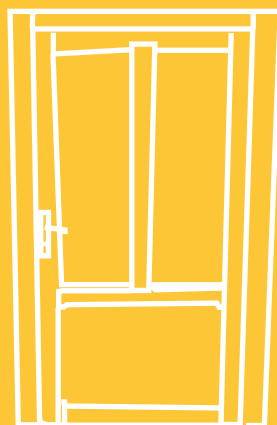
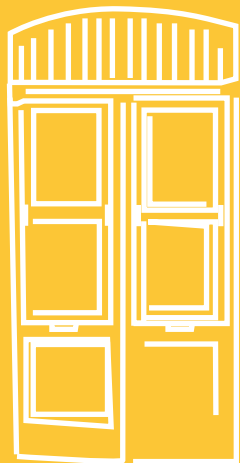

# Introduction

# INTRODUCTION

---

This 5-day intensive program brings together researchers and practitioners from all DESINC partner institutions, relevant guest speakers from academia, urban practice and CSOs, as well as other engaged students and educators. Participants will join forces to explore the interface between the reception and inclusion of refugees and international migrants in local urban areas, and the teaching of architecture, urban design, and urban planning. The aim of this week is to collectively develop pedagogical approaches and principles to make questions of migration and asylum more integral to the teaching of urban design and planning. The IPHEL 2 builds on the results of the IPHEL 1, held in Sheffield in December 2017.

The IPHEL 2 aims to support participants to:

1. Revise and refine the shared vocabulary and set of concepts developed during IPHEL1 that address issues of migration in local urban areas, according to DESINC partner progress on project deliverables.
2. In order to support the emergent needs of marginal groups, familiarise further with methods, tools and narratives that emphasise the agency of migrants and their contribution to city-making.
3. Share and analyse experiences in the field of engaged urban practice, action-learning and knowledge co-production, in order to create meaningful learning programmes and environments addressing questions of migration and inclusion in the field of architecture, urban design, and urban planning.
4. Examine a number of CSO-driven approaches for the welcoming of migrants in local urban areas, in order to distil lessons from these but also develop pedagogical tools that can match the learning and training needs of students, educators and CSOs in this field.
5. Advance the development of pedagogical principles and approaches, by engaging in discussion in an interdisciplinary environment, and advance further in the systematic evaluation of current curriculum design and teaching/training practices which can lead to a shared approach across DESINC partners.

The IPHEL 2 was co-designed and developed by the Designing Inclusion teams of KU Leuven, Housing Europe, University of Sheffield and ASF-International.

# GUEST SPEAKERS

---

## Afra Dekie

Afra Dekie is a visual anthropologist (and doctoral researcher) interested in exploring the ways 'illegality' and abjectivity are being lived and experienced by people without papers in Brussels. Afra uses visual methodologies to explore these experiences, but also in an attempt to merge research, creative practice and community work to give 'visibility' to excluded communities, strive for social and political change through creative visual practice, and engage in public debate on immigration through ethnographic practice.

## Jonas De Maeyer

Jonas studied architecture and urban planning. After having worked for several years in the field of architecture, landscape and urban design, he started focusing more on research and activism. At Parsons New School in New York he was involved in research on gentrification. He co-authored *Over de Rand*, a research project by OMGEVING concerning Ghent's urban fringe. In 2017 he co-founded Heim, a collective initiative focusing on arrival architecture and the integration of newcomers. Jonas is part of Endeavour, a platform for socio-spatial research and innovation based in Antwerp.

## Koen De Wandeler

Koen De Wandeler is trained as an architect and an anthropologist at the KU Leuven and the School of Oriental and African Studies. He acquired extensive experience in Asia, working as an academic and a consultant with a wide range of academic institutions as well as with various NGOs, national and international agencies. At present, he is engaged in research and teaching at the Faculty of Architecture of the KU-Leuven. His current research interests are on urban transition processes and temporality. Given his extensive experience in development issues in the Global South, he remains actively involved in various action research and consultancy networks.

## Minne Huysmans

Minne Huysmans holds a BSc in Socio-Educational Care Work, and a MSc in Adult Educational Sciences. He worked as a restorative justice mediator in Brussels, and conducted research at Odisee University College on 'the-right-to-the-city' in arrival districts of the Brussels Region. He is co-founder of (1) Growfunding, a civic crowdfunding platform in Brussels that focuses on bottom-up city making and (2) Volta, a music centre in Brussels for young and talented musicians in their transition from the pubscene to the professional clubcircuit. Minne is writing a PhD on future perspectives of young newcomers in an urban environment. His main research interests are: youth, citizenship, social support, and metropolitanism.

### **Maria Anita Palumbo**

Maria Anita holds a PhD in Social Anthropology and Ethnology from the EHESS, Paris. She is Associate Professor in Human and Social Sciences at the Saint-Etienne School of Architecture, member of the Research Team Transformations and research fellow at LAA / LAVUE / CNRS. Her privileged field of investigation focuses on the social and spatial margins that she apprehends in their relationship to the center (working class and ethnic neighborhoods, social and collective houses, *favelas*, *barrios*, squats). She is also interested in the circulation of urban models, and since 2014 has been co-conducting with Olivier Boucheron research on the transformation of collective housing projects by their inhabitants in Europe, Asia and Africa.

### **Petra Pferdmenges**

Through practice, research and teaching, Petra Pferdmenges (PhD) explores the role of the architect in co-producing the city. Her focus lies on Brussels, where she works on expanding architectural practice from 'built space' to 'lived space'. In 2010 she founded the spatial agency Alive Architecture based in Brussels after having practiced for five years in the internationally recognized architecture offices of Edouard François in Paris, France (2003-2004) and Josep Llinas in Barcelona, Spain (2006-2008). She is a researcher at KU Leuven - Campus Sint-Lucas Architecture since 2010, where she teaches design studios in the national and international Master of Architecture.

### **Marco Ranzato**

Marco Ranzato (PhD) is researcher at the Faculty of Architecture La Cambre Horta of the Université Libre de Bruxelles, coordinator of the LoUiSE research group for the laboratory of territorial engineering Metrolab, and co-director of LATITUDE Platform for Urban Research and Design. His research focuses on expanded understanding of ecological design, processes of horizontal urbanization, as well as on co-production of water, energy and waste services and co-design. He recently edited the book *Water vs. Urban Scape: Exploring integrated Water-Urban Arrangements* for Jovis.

### **Stéphanie Marques dos Santos**

Stephanie Marques dos Santos graduated in Law at the University of Louvain (UCL) and obtained a LLM from the European Academy of Legal Theory (FUSL & KUB). Her research investigates patterns of settlement of refugees in the city following their housing strategies and trajectories. Following the case of newly arriving Syrian and Iraqi refugees in Brussels, she explores the role of arrival neighbourhoods, as well as support networks (mainly the ones during and after the Maximiliaan Refugee Camp in Brussels), in determining these patterns. Her research interests extend to the understanding of informal networks and practices and she also continues to closely follow and participate in questions of urban activism and urban change in Beirut.

## **Jingjing Li**

Jingjing LI is currently a PhD candidate in social and cultural anthropology within the research team IMMRC at KU Leuven working on Engaged Urbanism through an exemplary case of Recyclart in the city of Brussels documenting and analyzing the transformation from dependence with permanent use of a place to temporary uses of urban spaces when confronted with urban eviction. She is also a researcher working on a project examining urban social housing employing interdisciplinary methods from anthropology and urbanism, a project collaborating with the OSA research team.

## **Jeanne Mosseray**

Jeanne Mosseray trained as an anthropologist at UCLouvain, where she conducted research on immigration and European cities. She pursued studies in Urbanism and Strategic Planning at the KU Leuven. Now, as an "urbanist-anthropologist", she is combining socio-eco-ethnic research and urban design. Her main research focus is on social housing neighborhoods and the residents' inclusion in the city through urbanism. Jeanne is currently a PhD candidate at Cosmopolis., VUB and OSA, KU Leuven. Her research project is called "SoHoLab: the regeneration of large-scale social housing estate through LivingLab".

### Min Tang

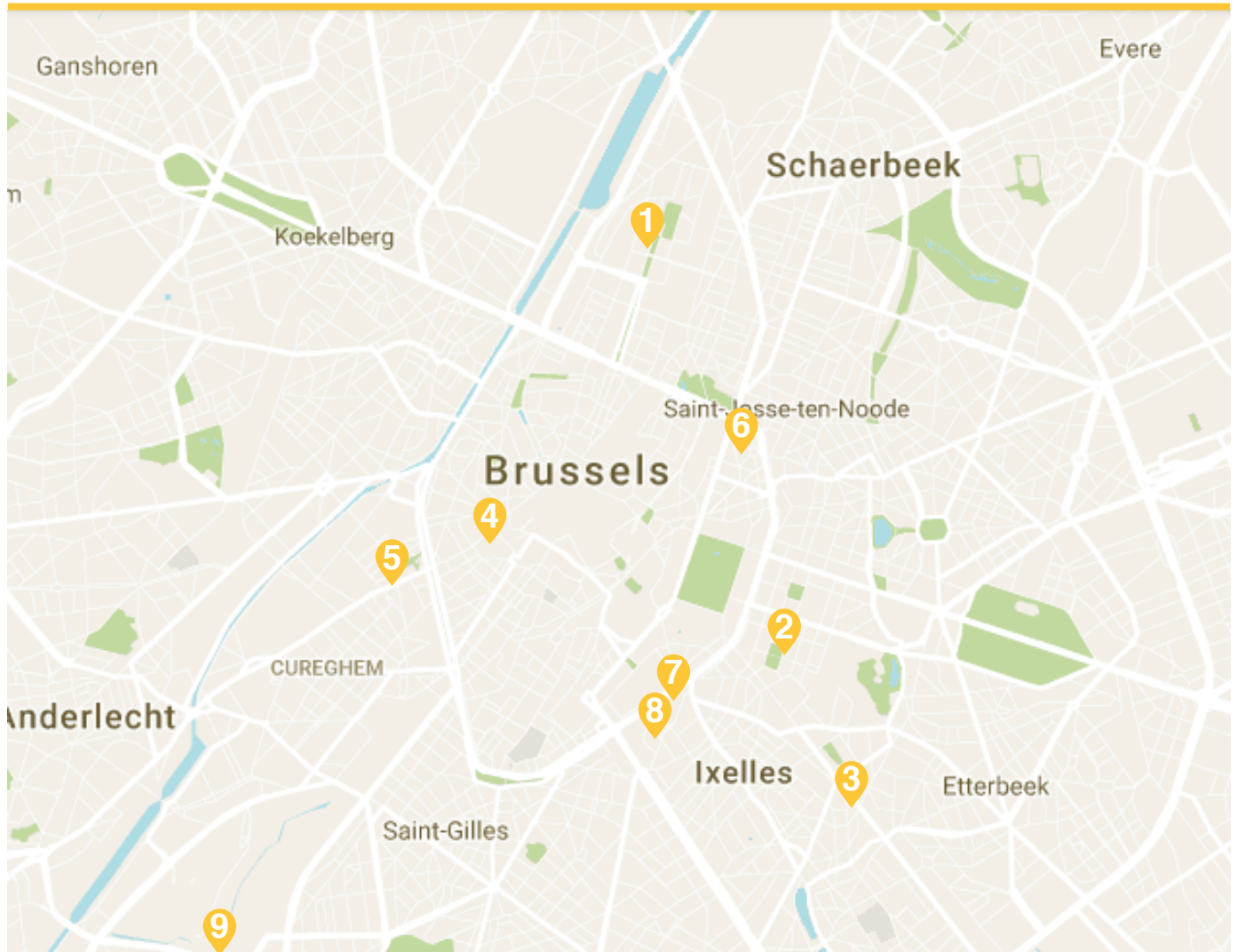
